Background

Introduction and Demographics

The purpose of this analysis is to examine distribution of gender and ethnicity in the ten residence halls available at UTC and identify any relevant differences in academic performance and retention. This analysis used undergraduate enrollment at the end of each Fall term from 2016 through 2019. Differences in academic performance were measured by comparing fall term GPA and one-year retention to the next fall. A list of residence halls with opening year and occupancy size are provided in Appendix A.

Enrolled students living in residence halls make up between thirty to thirty-four percent of all enrolled undergraduates. Majority students in all residence halls are women and white. Annually, over sixty percent are female, and seventy percent of on-campus students are white. Freshman (47%) were most likely to live in residence halls, followed by sophomores (29%), juniors (14%), and seniors (9%). Less than one percent were non-degree undergraduates.

For students of color, campus residents are primarily Black or African American. A large proportion of African American and Hispanic who enroll also choose to live on campus. On average, half of all enrolled African American undergraduates (μ = 529) and one-third of all Hispanic undergraduates (μ = 155) live in a residence hall.

In comparing the population distribution of all residence halls, two of them deviate from the rest in gender ratio and ethnic diversity. Most residents in Boling apartments were men until Fall 2019 when the percentage of male residents dropped fourteen percent (Appendix B). In the same span of time, male residency in Johnson Obear apartments increased by twelve percent. Stophel apartments house most students of color, especially African Americans (Appendix C). For the past four years, approximately thirty percent of all African American residents, or fifteen percent of all African American undergraduates, lived in Stophel. The least diverse residence halls are Guerry and Stagmaier apartments, where the percentage of non-white residents ranges between fifteen and twenty percent.

Academics

Term GPA

When viewing academic performance for all undergraduates living on or off campus, Stagmaier residents rise to the top. For the last three years, Stagmaier, UC Foundation, and Walker apartment students earned a higher Fall GPA than their counterparts; this is especially true for female residents. Women in general earned a higher Fall GPA than all undergraduates.

Both male students and students of color demonstrated lower GPA earnings than other undergraduate residents for the past four years, especially those living in Lockmiller and West Campus. Overall, male students in Lockmiller earned the lowest Fall GPA in all four terms. Both men and students of color in West Campus earned a significantly higher Fall GPA than Lockmiller but are still lower than their peers in all other residences (Appendix D).




Retention Rates

One-year retention rates follow a similar trend to academic performance. All residence halls hold a significantly higher retention than off-campus students. Stagmaier, Stophel, and UC Foundation retention gradually increased with Stagmaier holding an overall retention of more than eighty percent for the last three years. Bowling and Johnson-Obear saw a gradual decrease in retention over the same span of time. However, more students are also graduating as these are residence halls primarily for upperclassmen.

In reviewing the residence halls with lower retention, three are of note: Lockmiller, West Campus, and Stophel. Across all four years, Lockmiller holds one of the lowest retention rates, especially among male students. Fewer male residents in Lockmiller are retained to the subsequent fall across the last four years. West Campus housing showed a lower retention than other residence halls after its initial opening in Fall 2018, but it saw an increase in retention the following year. For Stophel, students of color had a very slight increase in retention over the years, and more than ten percent of residents have graduated each year (Appendix E).

Mean One Year Retention: Fall 2016 through Fall 2019






Freshman Cohort Performance


As Stagmaier, Lockmiller, and West Campus are primarily freshman housing residences, retention and Fall GPA metrics for first-time full-time freshman were also examined. Overall, the findings discussed above for all student residents apply to each freshman cohort. Stagmaier leads the residence halls in student retention and academic performance, while Lockmiller and West Campus display lower academic performance and fewer students retained. UC Foundation freshmen earned lower term GPAs than other residence halls, but their retention rate has been increasing over the last four years. Surprisingly, Walker apartments had one of the highest retention rates for Fall 2019. However, further investigation found that the number of freshmen staying in Walker was small (n = 25; Appendix F).

When comparing outcomes between on- and offcampus first time freshmen, all residence halls except Lockmiller display higher academic performance and retention. Off-campus freshmen share a similar retention to Lockmiller freshmen over the last four years. However, they received a lower Fall GPA by a mean difference of 0.06. In the last two years, both groups saw increases in GPA and retention, resulting in nearly equal performance between both groups (Appendix D).

Conclusion

Insights

The contrast in performance and retention between students who stay in Stagmaier versus Lockmiller or West Campus is interesting as all of these residencies are primarily for freshman students. Structurally, the primary difference between the residence halls is that Stagmaier's room type is a private suite, whereas the majority of Lockmiller and all of West Campus are shared rooms. The differences in academic performance and retention could be caused in part to difficulties adjusting to a shared living space. When comparing these three residencies with Guerry apartments, which has an equal amount of shared and private room type apartments for freshman, there appears to be a coinciding trend between GPA and retention and the ratio of available private rooms to shared rooms.

A second finding is the high concentration of African American students living in Stophel apartments compared to other residence halls. While Stophel has housed thirty percent of African American residents, all other residence halls held less than ten percent except UC Foundation (12.6%), West Campus (11.9%), Johnson Obear (10.7%), and Decosimo (10.1%). Considering the ratio of all African American undergraduates staying in Stophel, I believe it would be worthwhile to survey Stophel students to see why they choose to live there.






Appendix B. Residence Hall Populations: Gender








Appendix C. Residence Hall Populations: Ethnicity





Appendix E. One Year Retention: 2016 through 2019












































Appendix F. First-time Freshman Retention by Cohort
